#### Housing for Hebden

Our plans to bring back much needed affordable homes to High Street are progressing.

Contractors were recently on site digging trenches and bore holes to learn more about the condition of the proposed location; the report is due soon though early indications are promising. We also undertook air quality measuring on the site across last year with the report just in, and the good news is that the air is good where the homes would be. And our architects are working on some design aspects that reflect comments made at the public consultation we held in November. The situation in the building market is not so promising though, with price inflation and volatility both high. Many developers and housing associations are currently having to postpone their own development plans until (hopefully) the market settles down.

So things remain uncertain. However we know that we definitely need to secure planning consent before funders commit to a firm level of financial support and contractors commit to a price. Only then will we find out for sure if the scheme is financially viable. This is not ideal, given the uncertainty a planning application entails, but it is the necessary next step which we hope shortly to take.

# Hebden Bridge Signal box

We are now at the stage where Network Rail have instructed their solicitors to draw up the lease for the Signal Box. We are a little frustrated that the process has taken so long, but it appears that we are nearly there. After we have signed the lease, we will be able to move ahead with the refurbishment work. Fortunately, the National Lottery Heritage Fund and the Railway Heritage Trust have been extremely understanding about the delays, and our grants are still waiting for us.

### Forging a future at Foundry Street

Three CVCLT trustees were given a guided tour of the Foundry Street community centre in Sowerby Bridge the other day, where we shared our own experiences informally with the new group that's come together to try to take over the centre in an asset transfer from the council. We also put the group in touch with our friends at Todmorden Community College (TLC), now community-run following a successful asset transfer.

# Putting the Calder Valley on the map

People down south may be notoriously vague about northern geography, but at least we were able to put our valley on the map (and talk about our work in the CLT) on March 17 to the hundred or so delegates at the Town & Country Planning Association's conference at the Coin Street centre on London's South Bank. The event was focused on good practice in ensuring long-term stewardship of community assets. We were delighted to be asked to speak. (It was our Secretary Andrew who went down to London, one of his last engagements for the CLT before – as we reported last month - he steps down from our board at the AGM).

#### Working out our social impact

There's a long tradition of conventions for financial accounting, but there's much less to go on when it comes to trying to measure our social and environmental impact. We produced our first short social impact report last year and we propose to include something similar in this year's Trustees' Report and 2021 Financial Accounts (the document we will bring to members at the June AGM). But longer-term, we want to try to assess the CLT's social and environmental performance as rigorously as possible.
