Hebden Bridge - another step forward

We're very pleased to be able to report that we expect to put our planning application in for our proposed development at High Street, Hebden Bridge (near the Fox and Goose) by mid May. We are proposing a development of twenty homes, built to a high environmental standard, on land which once was packed with terraces and back-to-back houses.

We have changed the proposals significantly since our earlier proposals in 2018-2019, moving the buildings further away from Bridge Lanes and to an area where we know the air quality is safe. We hope very much that the town will welcome what will be an innovative green settlement of affordable housing fit for the rest of the century.

And what next?

It will take some weeks for Calderdale to 'validate' our planning application, after which there will be a period when the details are on the council's planning portal and everyone can formally comment on the scheme. We'll let you know when validation has happened.

Getting planning consent is just the next step for our plans, but it will enable us then to approach potential funders, as we try to put together the complete funding package.
